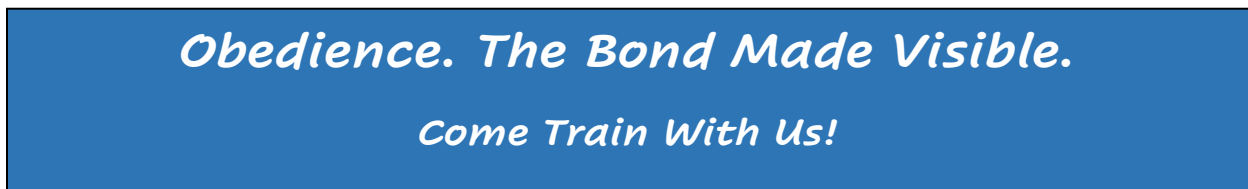

ROUTES TO THE SHOW

From Center City Philadelphia:

Take I-76 West to Exit 340B/US 1 North. Follow US 1 for 2.3 miles to the PA-611/Broad Street exit. Turn left onto North Broad Street, and continue to follow PA-611 North for 9 miles. Turn right onto Davisville Road. Less than 3/4 mile on the right, you will see a sign for "Rems Automotive" on the left. About 1/10 mile further along on the RIGHT, you will see the sign and driveway for Premier Office Solutions. Turn into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From PA Turnpike:

Take Exit 343 for PA-611 North toward Doylestown and continue about 3/4 mile. Make a sharp right onto Mill Road. Take the first right onto PA-263 South/York Road and proceed 1/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From Northern Suburbs:

Take PA-611 South. In Horsham, turn left onto Horsham Road and proceed about 1 mile. Turn right onto PA-263 South/York Road and proceed 3/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Entry and Payment Information

- ❖ **OPTION A:** Enter by mail, with a paper entry form and send a check or money order.
- ❖ **OPTION B:** Enter and pay electronically. There are two steps — entry and payment. Both must be complete before your entry can be processed.
 - **Step 1: Entry:** Email a scanned copy of your completed and signed entry form to the Trial Secretary.
 - Entries must be completed and signed in accordance with AKC rules.
 - Senders of illegible or incomplete transmissions will be notified by email.
 - **Step 2: Payment.** You can pay electronically either via PayPal or Zelle:
 - PayPal Payment — Added convenience fee of \$3.00.
 - Go to the PDTC website Obedience Trial page: www.philadelphiadogtraining.org/html/obedience_trial.html. Use the PayPal menu to submit your payment. You must enter your dog's AKC number along with the number of classes being entered.
 - Zelle Payment
 - Pay online via Zelle from your online access to your bank account. You must enter your dog's AKC number along with the number of classes being entered in the memo field. Send payment to pdtcinc@gmail.com.
 - Opening (March 8, 2023) and closing dates still apply. Both the fully completed entry form and the PayPal or Zelle payment must be date/time stamped after the opening date. If either is sent early, per AKC rules the entry cannot be accepted or processed. Likewise, both entry form and payment must be received by closing. Confirmation of transmission is not proof that your entry has been successfully received.
- ❖ Classes will close when entry limits are reached. A notice will be posted as soon as practicable on the Club website when/if this occurs.
- ❖ If you don't receive your email entry confirmation within a reasonable amount of time, please contact the Trial Secretary to confirm receipt.

NOTICE TO EXHIBITORS

CLOSING DATE FOR ENTRIES: 8:00 PM, Wednesday April 26, 2023, (at the Trial Secretary's address) after which time entries cannot be accepted, cancelled, or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules.

An AKC RECORDING FEE of \$0.50 and an AKC Event Service Fee of \$3.00 will be required for each dog entered at any Licensed or Member Club Show, Obedience Trial, or Tracking Test. If a dog is entered in more than one class in one of these events, the AKC Recording Fee and Service Fee are to be collected on the first entry only (AKC Rules Applying to Dog Shows, Chapter 11, Section 2). All Recording Fees are paid to the AKC.

MAIL ALL ENTRIES WITH FEES TO: SUSAN L. ANDERSON, c/o Liz Alakszay, 1435 Gary Terrace, West Chester, PA 19380-1416. No hand delivery of entries. Overnight deliveries must have "NO SIGNATURE REQUIRED". Acknowledgement of entries will be made as soon as practicable. If no acknowledgement is received by the exhibitor within a reasonable time, please notify Trial Secretary. Entries not on an official AKC entry form or photocopies of an entry form without the agreement will not be accepted. Entries received without fees or a signature will not be accepted. No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance.

MAKE ALL CHECKS AND MONEY ORDERS PAYABLE TO: PHILADELPHIA DOG TRAINING CLUB, INC. (PDTC). Trial Secretary assumes no responsibility for cash sent through the mail. Canadian exhibitors make fees payable in U.S. FUNDS.

RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

ENTRY SERVICES: If you use an entry service (e.g., superintendent or online entry service) other than the Trial Secretary listed in the Premium, please be aware of their terms, additional charges, and delivery policies.

CONFIRMATIONS: ALL entries will be confirmed by email, regardless of how they arrive. EXHIBITORS WILL RECEIVE ALL COMMUNICATION, INCLUDING CONFIRMATION AND JUDGING SCHEDULE VIA EMAIL.

ENTRY FEES shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee, or an exhibitor is removed for violating covid19 protocols. If because of riots, civil disturbance, or other acts beyond the control of the management it is impossible to open or complete the show, no refund of entry fees will be made.

EXTREME WEATHER CONDITIONS, such as, but not limited to snowstorms, hurricanes, lightening, extreme heat must be considered for the health and safety of the dogs, exhibitors, and spectators. The well-being of dogs, exhibitors, and spectators is of paramount importance and, in the event if is necessary to cancel or stop the show before completion, no refund of entry fees will be made. If cancellation is decided before the event, notification will be posted on PDTC's website www.philadogtrainingclub.org.

BITCHES IN SEASON are not permitted to compete. PDTC will refund all but a \$10 administrative fee of the entry fee for bitches unable to compete for that reason. The Trial Secretary must be notified of such claim for refund either hand-delivered no later than 30 minutes prior to the start of the first class in the trial or by letter postmarked by May 8, 2021, or earlier. Refund requests must be made in writing. Email and phone requests will not be considered.

ERRORS ON ENTRY FORMS. Owners are responsible for errors in making out entry forms, whoever may have made such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

NO REFUND FOR DUPLICATE ENTRIES. We will make every effort to find all duplicate entries, but if a dog has been processed, no refund will be made.

DOGS MAY ARRIVE any time prior to their scheduled time of judging.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the ring when their class is called to be judged. ALL DOGS must be on leash or confined to a crate except when being judged.

CHILDREN: Parents must be responsible for their children at all times.

HEALTH: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

DECLINATION OF ENTRIES/REMOVAL OF DOG: The show committee may refuse to admit or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against the show-giving club or any official thereof.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
