Attention Exhibitors

FOOD: Coffee and snacks will be available. Feel free to bring refreshments. NO people food or drinks allowed on turf.

CANINE COURTESY: All dogs are to be kept under control at all times. All dogs present must be held on leash or confined to their crates except when being judged. Retractable leashes may NOT be used on show grounds. Designated exercise areas will be available. Exhibitors who fail to clean up after their dogs anywhere on show grounds, including outside the facility, will be subject to an Event Committee hearing and a fine.

PUPPIES: Per the Rules Applying to Dog Shows, only dogs that are eligible to be shown at this event shall be allowed within the show precincts. Please leave dogs under 6 months old at home.

ARRIVAL: Dogs may arrive any time prior to their scheduled time of judging.

JUDGING: Judges will not wait for any dog holding up a class. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called.

PRACTICING: No practicing allowed in rings at any time. A practice ring will be available.

CRATING: Please provide your own chairs and crates. Pads/tarps ***must*** be provided under crates.

RESTROOMS: No dogs allowed in restrooms or adjacent corridors.

HEALTH: Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

SMOKING: No smoking allowed in the building.

CHILDREN: Parents must be responsible for their children at all times.

UNLOADING: Unloading will be allowed only in designated areas and vehicles must be removed within a reasonable time.

EMERGENCIES: This area is serviced by 911 Emergency Medical Response.

ROUTES TO THE SHOW

From Center City Philadelphia: Take I-76 West to Exit 340B/US 1 North. Follow US 1 for 2.3 miles to the PA-611/Broad Street exit. Turn left onto North Broad Street, and continue to follow PA-611 North for 9 miles. Turn right onto Davisville Road. Less than 3/4 mile on the right, you will see a sign for "Rems Automotive" on the left. About 1/10 mile further along on the RIGHT, you will see the sign and driveway for Premier Office Solutions. Turn into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From PA Turnpike: Take Exit 343 for PA-611 North toward Doylestown and continue about 3/4 mile. Make a sharp right onto Mill Road. Take the first right onto PA-263 South/York Road and proceed 1/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From Northern Suburbs: Take PA-611 South. In Horsham, turn left onto Horsham Road and proceed about 1 mile. Turn right onto PA-263 South/York Road and proceed 3/4 mile. Turn left onto Terwood Road. After 1/2 mile, make a right onto Davisville Road. Watch for a "Tires Plus" sign on the right. Approximately 100 yards further along on the LEFT, you will see the sign and driveway for Premier Office Solutions. Turn left into the drive, go past the side of the building and turn left behind it. Drive down the very long parking area, parallel to the building. Y2K9s is at the opposite end, and so is our entryway.

From Western Suburbs: Take I-476 North (Blue Route) to the PA Turnpike/I-276 East. Follow directions from Exit 343 as above.

From NJ: From Hunterdon County area, take US-202 South to PA-611 South and follow directions above. From Mercer or Burlington Counties, take the PA Turnpike West and follow directions above.
